

ACKNOWLEDGEMENT

I have read the Clearview Memorial Forest Policy and by signing below, acknowledge the following:

The Memorial Forest Sub-Committee will implement best efforts to ensure that the Memorial Forest and each Memorial Tree is properly maintained. However, the Committee cannot guarantee trees against acts of vandalism, damage or failure as a result of environmental stresses or conditions which may impact negatively on the health of a Memorial Tree.

Following the purchase of the Memorial Tree, a three (3) year warranty period from the date of purchase of the tree, shall apply. During this warranty period, the Memorial Tree shall be replaced two (2) times if it is unsuccessful in surviving. If the Memorial Tree is unsuccessful in surviving either following these two (2) replacements, or at conclusion of the warranty period, either of the following actions may be taken at the sole discretion of the Memorial Forest Sub-Committee:

- 1) The planting of the same or similar tree species shall be completed at an alternate location within the Forest, and the existing plaque will be moved accordingly. Should an amendment to the plaque be required to recognize the difference in tree species, this shall be the responsibility of the Committee; OR
- 2) The plaque will be moved to another tree of the same species within the the Forest. If an existing tree of the same species is not available, a tree of a different species may be selected by the purchaser (with Committee assistance), with any required amendments to the plaque to recognize the different tree species being the responsibility of the Committee.

ABOUT THE MEMORIAL FOREST PROGRAM

The Memorial Forest is located on Mowat Street North, on the land next to the Eco Park, which was donated by Clearview Township.

A living tree is symbolic of the ongoing memories of your loved one. By planting a tree, you preserve these precious memories and encourage the preservation of nature for our future generations.

Family members can dedicate a tree in memory of a loved one. A memorial plaque is placed at each tree with wording according to the families request.

The Memorial Forest Tree Program provides a means for members of the public to recognize & honour each other in a lasting tribute.

Contributions also benefit the community, providing natural beautification and enhanced forest cover.

The Forest is administered by Clearview Parks and Recreation Staff and Volunteers, with members of the Stayner Lions Club as part of a sub-committee.



HOW TO ORDER

COST

The cost for a Memorial Tree is \$350 which includes a memorial plaque.

ORDER PROCESS

Submit the attached Application and Acknowledgement Form along with a cheque payable to "Township of Clearview". An on-site meeting will be arranged to select a tree and complete details regarding the plaque.

The Sub-Committee will then recognize the Memorial Tree as being purchased and will arrange for placement of the plaque. A standardized memorial plaque will be placed in the vicinity of the selected Memorial Tree. Ordering and placement of the memorial plaque shall be completed by the Committee. An application letter will then be issued to the purchaser along with a tax receipt.

WARRANTY

Although best efforts shall be made to provide for selection of a tree of the purchaser's choice, final discretion shall be maintained by the Memorial Forest Sub-Committee. When purchased, the tree will include a three (3) year warranty period. Best efforts will be made to ensure that the Memorial Forest and each Memorial Tree is properly maintained.

PLACEMENT OF DECOR

In an effort to ensure appropriate grounds maintenance operations and to ensure general consistency and aesthetics within the Memorial Forest, the placement of decorations or other additional private memorial items within the forest shall be prohibited. This shall also include additional private landscaping and other aspects of altering the area at/around Memorial Trees. The Memorial Forest Sub-Committee shall remove and dispose of any such items placed in the Memorial Forest.
